

# SUBSTANCE WEEKLY REPORT



Apr 28<sup>th</sup> - May 4<sup>th</sup> 2025 (123 Samples)

## HIGHLIGHTS

- 58.5% (72/123) of samples checked were as expected, with no cuts or adulterants detected
- 18.2% (10/55) of down samples contained a benzo this week

## DOWN/OPIOIDS, 55 SAMPLES

- 40 samples contained **fentanyl** at a median concentration of 3%
- 25 samples contained **fluorofentanyl** at a median concentration of 5%
- 6 samples contained **ortho-methyl fentanyl** at a median concentration of 1%
- 9 samples contained **heroin** at a median concentration of greater than 11%
- 4 samples contained **xylazine** at a median concentration of 4%
- 8 samples contained **medetomidine** at a median concentration of 3%
- 10/55 down samples contained a **benzo**
  - 7 samples contained **bromazolam** at a median concentration of 2%
  - 2 samples contained an **unknown benzo**
  - 1 sample contained **desalkylgidazepam** at a concentration of 16%

### Community Reporting (from last week)

- **Down:** Small purple pebbles/powder. When smoked, tasted strong. Effects were somewhat stronger than expected, felt "benzo-ey". Bought north of downtown.
- **Down:** Big purple/pink chunks. When cooked, turned dark down. When smoked, the resin was sticky. Effects were somewhat stronger than expected. Bought in the downtown area.

## BENZOS, 3 SAMPLES

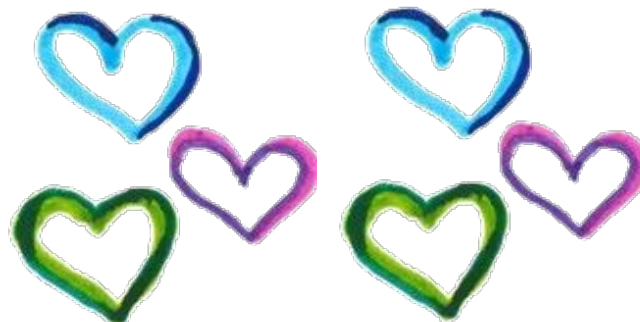
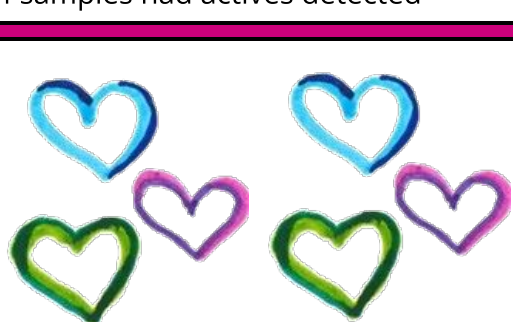
- 0/3 samples were **alprazolam (Xanax)**
- 3 samples contained **bromazolam** instead

## UNKNOWN, 4 SAMPLES

- 4 samples was brought in as "unknown"
- 4 samples had actives detected

## DISSOCIATIVES & PSYCHEDELICS, 9 SAMPLES

- 5/5 samples were **ketamine**
- 2/2 samples were **2C-B**
- 1 sample was **4-AcO-DMT (O-Acetylpsilocin)**
- 1 sample was **DMT (Dimethyltryptamine)**

## STIMULANTS, 41 SAMPLES

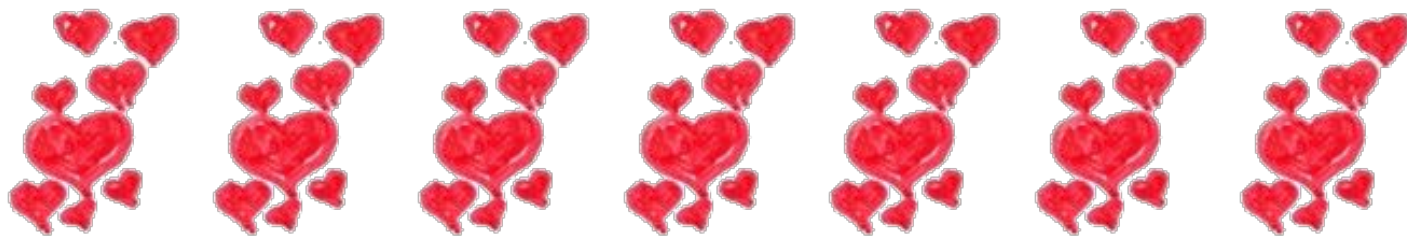
- 19/19 samples were **cocaine** (hard and soft)
- 1 sample was **MDA**
- 16/18 samples were **MDMA**
  - 1 sample also contained **MDA**
  - 1 sample was **MDA** instead
- 1 sample was **methamphetamine**
- 0/2 samples were **amphetamine**
  - 2 samples contained **methamphetamine** instead

### Community Reporting (from last week)

- **Side:** Clear shards. Effects were as expected.

## OTHER, 10 SAMPLES

- 1/3 samples were **hydromorphone (Dilaudid)**
  - 1 sample was did not have any actives detected
  - 1 sample was an **unknown nitazene** instead
- 1 **oxycodone (Oxycontin)** sample did not have any actives detected
- 2/2 samples were **Percocet (oxycodone + acetaminophen)**
- 1 sample was **sildenafil (Viagra)**
- 1 **metandienone (Dianabol)** sample was **methandrostenolone** instead
- 2/2 samples were **oxandrolone**



## REPORT GLOSSARY

- **Community Reporting:** These sections include reports from community members throughout Victoria. Samples within these sections may or may not have been checked at Substance.
- **Median:** Like an average, but accounts for outlying results so the final number isn't skewed.
- **Percentages:** Represents the amount per 100 mg. Example: a concentration of 12% fentanyl is 12 mg of fentanyl per 100 mg (a point) of the total sample (including other components like cuts).
- **Unknown benzo:** A benzo that is likely outside of our PSMS target list.
