

SUBSTANCE WEEKLY REPORT



August 25th - August 31st, 2025 (107 Samples)

HIGHLIGHTS

- 70.4% (76/107) of samples checked were as expected, with no cuts or adulterants detected
- 24.0% (6/25) of down samples contained a benzo this week

DOWN/OPIOIDS, 25 SAMPLES

- 18 samples contained **fentanyl** at a median concentration of 12%
- 14 samples contained **fluorofentanyl** at a median concentration of 2%
- 9 samples contained **ortho-Methyl fentanyl** at a median concentration of 0.7%
- 1 sample contained **carfentanil** at a concentration of 0.25%
- 2 samples contained **heroin** at concentrations of 1% and greater than 50%
- 3 samples contained **medetomidine** all at a concentration of 2%
- 1 sample contained **xylazine** at a concentration of 8%
- 6/25 down samples contained a **benzo**
 - 4 samples contained **desalkylgizapam** at a median concentration of 0.5%
 - 3 samples contained **bromazolam** at concentrations of 0.9%, 3%, and 6%

Community Reporting (from last week)

- **Down:** Purple pebbles. When smoked, had a strong caffeine taste. Effects weaker than expected. Bought in downtown area.



BENZOS, 8 SAMPLES

- 2/2 sample were **alprazolam (Xanax)**
- 1 sample was **bretazenil**
- 0/2 samples were **bromazolam**
 - 2 samples were an **unknown benzo** instead
- 1 sample was **etizolam**
- 1 sample was **flualprazolam**
- 1 **fluclozepam** sample also contained **ibuprofen**

DISSOCIATIVES & PSYCHEDELICS, 28 SAMPLES

- 17/17 samples were **ketamine**
- 1 sample was **fluorodeschloroketamine**
- 1 **3-HO-PCP** sample was **3-HO-PCE** instead
- 6/6 samples were **2C-B**
- 1 sample was **4-HO-MET**
- 1 sample was **LSD**
- 1 **tucibi** sample contained **ketamine** and **MDMA**

OTHER, 8 SAMPLES

- 2/3 samples was **GHB**
 - 1 sample did not have any actives detected
- 2/2 samples were **hydromorphone**
- 1 sample was **oxycodone (Oxycontin)**
- 1/2 samples were **Percocet**
 - 1 sample was an **unknown nitazene** instead

STIMULANTS, 35 SAMPLES

- 8/9 samples were **cocaine** (hard and soft)
 - 1 **cocaine** (hard) sample also contained **phenacetin**
- 10/11 samples were **MDMA**
 - 1 sample was **MMDA** instead
- 4/4 samples were **methamphetamine**
- 2/2 samples were **3-MMC**
- 2/2 samples were **4-MMC**
- 2/2 samples were **amphetamine**
- 1 sample was **methylmethamphetamine**
- 1 sample was **alpha-PHP**
- 1 sample was **alpha-PHiP**

Community Reporting

- **Meth/side:** White shards. Pleasant experience smoking. Melted well, produced a white resin. Effects as expected. Bought in North Park area.

UNKNOWN, 3 SAMPLES

- 3 samples were brought in as "unknown"
 - 0 samples had actives detected

REPORT GLOSSARY

- **Community Reporting:** These sections include reports from community members throughout Victoria. Samples within these sections may or may not have been checked at Substance.
- **Median:** Like an average, but accounts for outlying results so the final number isn't skewed.
- **Percentages:** Represents the amount per 100 mg. Example: a concentration of 12% fentanyl is 12 mg of fentanyl per 100 mg (a point) of the total sample (including other components like cuts).
- **Unknown benzo:** A benzo that is likely outside of our PSMS target list.
