

SUBSTANCE WEEKLY REPORT

December 15th - 31st, 2025 (298 Samples)



HIGHLIGHTS

- Happy New Year!
- 68.5% (204/298) of samples were as expected, with no cuts or adulterants detected
- 27.0% (20/74) of down samples contained a benzo

DOWN/OPIOIDS, 74 SAMPLES

- 57 samples contained **fentanyl** at a median concentration of 15%
- 30 samples contained **fluorofentanyl** at a median concentration of 8%
- 11 samples contained **heroin** at a median concentration of 2%
- 7 samples contained **medetomidine** at a median concentration of 0.6%
- 4 samples contained **carfentanil** at a median concentration of 0.7%
- 2 samples contained **ortho-methyl fentanyl** at concentrations of less than 1% and 1%
- 1 sample contained **xylazine** at 0.7%
- 20/74 down samples contained a **benzo**
 - 10 samples contained **ethylbromazolam** at a median concentration of 6%
 - 4 samples contained **bromazolam** at a median concentration of 5%
 - 4 samples contained **etizolam** at a median concentration of 8%
 - 1 sample contained **desalkylidiazepam** at a concentration of less than 1%

Over the Past Four Weeks...

- 85 samples contained **fentanyl** at a median concentration of 14%
- 42 samples contained **fluorofentanyl** at a median concentration of 8%
- 10 samples contained **bromazolam** at a median concentration of 5%
- 9 samples contained **medetomidine** at a concentration of 1%

STIMULANTS, 125 SAMPLES

- 48/58 samples were **cocaine** (hard and soft)
 - 1 **cocaine** (hard) sample was fentanyl instead
 - 1 **cocaine** (hard) sample did not have any actives detected
 - 5 **cocaine** (soft) samples also contained **levamisole**
 - 1 **cocaine** (soft) sample also contained **MDMA**
 - 1 **cocaine** (soft) sample also contained **ketamine**
 - 1 **cocaine** (soft) sample also contained **acetaminophen**
- 4/4 samples were **MDA**
- 38/44 samples were **MDMA**
 - 1 sample also contained **methamphetamine**
 - 1 sample was **MDA** instead
 - 1 sample did not have any actives detected
- 12/13 samples were **methamphetamine**
 - 1 sample was **ketamine** instead
- 1 sample was **3-MMC**
- 2/4 samples were **4-MMC (Mephedrone)**
 - 1 sample also contained an unknown
 - 1 sample also contained **4-MDMC (4-methyldimethcathinone)**
- **1/2 samples were amphetamine**
 - 1 was methamphetamine instead
- 1 sample was **lisdexamfetamine (Vyvanse)**
- 1 sample was **methylphenidate (Ritalin)**

BENZOS, 20 SAMPLES

- 5/7 samples were **alprazolam (Xanax)**
 - 1 sample was **etizolam** instead
 - 1 sample was an **unknown benzo** instead
- 2/2 samples were **etizolam**
- 2 **pyrazolam** samples did not have any actives detected
- 1 sample was **avizafone**
- 1 sample was **bretazenil**
- 1 sample was **bromazolam**
- 1 sample was **diazepam (Valium)**
- 1 sample was **ethylflualprazolam**
- 1 sample was **flualprazolam**
- 1 **meclonazepam** sample was **3-hydroxy desalkylidazepam** instead
- 1 unspecified benzo was **flualprazolam**
- 1 unspecified benzo was **clonazepam (Klonopin)**

OTHER, 18 SAMPLES

- 1/2 samples were **GHB**
 - 1 sample also contained **GBL**
- 1 sample was **zolpidem (Ambien)**
- 4/4 samples were **hydromorphone (Dilaudid)**
- 1 sample was **MGM-15**
- 1 sample was **morphine**
- 2/2 samples were **oxycodone (Oxycontin)**
- 1 sample was **Percocet**

DISSOCIATIVES & PSYCHEDELICS, 50 SAMPLES

- 36/36 samples were **ketamine**
- 1 **FXE** sample was **2-fluoro-2-oxo-PCE** instead
- 1 sample was **O-PCE**
- 4/4 samples were **2C-B**
- 1 sample was **4-HO-MET**
- 1/2 samples were **5-MeO-DMT**
 - 1 sample also contained an unknown
- 1 **5-MeO-MiPT (Moxy)** sample also contained an unknown
- 2/2 samples were **LSD**
- 1 **psilocybin (mushrooms)** sample did not have any actives detected
- 1 **tucibi** sample was **ketamine** and **MDMA**

UNKNOWN, 11 SAMPLES

- 11 samples were brought in as "unknown"
 - 2 samples had actives detected

OTHER, 18 SAMPLES (CONTINUED)

- 1 sample was **5-APB**
- 1 sample was **clomiphene**
- 1 sample was **ivermectin**
- 1 sample was **mebendazole**
- 1 sample was **oxandrolone**
- 1 sample was **trenbolone enanthate**

REPORT GLOSSARY

- **Community Reporting:** These sections include reports from community members throughout Victoria. Samples within these sections may or may not have been checked at Substance.
- **Median:** Like an average, but accounts for outlying results so the final number isn't skewed.
- **Percentages:** Represents the amount per 100 mg. Example: a concentration of 12% fentanyl is 12 mg of fentanyl per 100 mg (a point) of the total sample (including other components like cuts).
- **Unknown benzo:** A benzo that is likely outside of our PSMS target list.
